

Know Your Client

- Review Family Background
- Research Client's Court History
 - Review Clerk's File/Other Jurisdiction Files
 - Review DJJ File § 7B-3001
 - Review Client's Disposition Level § 7B-2508
- Request and Review Records
 - Department of Social Services School Records

 - Medical Records

Know The Code

- Remember that the Court may:

 - Dismiss the Case § 7B-2501(d)
 Continue the Case § 7B-2501 (d)
 - Order Evaluation and Treatment § 7B-2502
- Review Statutory Options § 7B-2506

 - Community (Level 1) Intermediate (Level 2)
 - Commitment (Level 3)

Level 1

Community Disposition 7B-2506 (1)-(13)

- General Supervision, Placement w/ DSS
- Alternative Schooling
- Community Based/Substance Abuse/Residential or Nonresidential Program
- Restitution (up to \$500)

- Community Service (up to 100 hours)
 Intermittent Detention (up to 5 days)
 Victim-Offender Reconciliation Program
- No Association with Specified Persons/Places Suspension of Driver's License
- Wilderness Program
- Probation
- Curfew
- Fine

Level 2

Intermediate Disposition 7B-2506 (13)-(23)

- Wilderness Program
- Intensive Probation
- Supervised Day Program
- Regimented Training Program
- Suspend Disposition with Conditions
- Placement in Multipurpose Group Home
- Restitution (over \$500)
- Community Service (up to 200 hours)
- Intermittent Detention (up to 14 days)
- House Arrest

Level 3- Commitment § 7B-2506 (24)

- Only Level 3 Disposition
- A Minimum of Six Months
- Special Rules:
 - Minor offense can become Major (Commitment) if your Client has been adjudicated of four or more prior offenses.
 - Level 2 can become Level 3 if Client has been to YDC.
 - Level 3 can become Level 2 if you show extraordinary needs.


Know The Court

Reiterate Goals and Aims of Juvenile Court

- Give "Opening Statement" that:
 - Emphasizes need for services for Client and family
 - Focuses on helping Client become a healthy, successful and productive citizen
 - Discusses Redemptive and Rehabilitative nature of Juvenile Justice System

Reintroduce Your Client

- Discuss Client's Goals and Interests
- Highlight Client Success
 - Academics, Arts, Athletics
 - Character and Commitment
 - Milestones (e.g. 54 days sober)
- Let your Client Speak!

Remind Court of Special Issues and Challenges

- Substance Abuse
- Mental/Medical Health
- Physical Challenges
- Education Concerns
- Emotional or Therapeutic Needs
- Family Dynamics
- Domestic or Gang Violence
- Financial Difficulties

Prepare Your Own Recommendations and Report

■ Recommendations

- Ask for Dismissal § 7B-2501(d)
- Request "Family" Disposition § 7B-2501(d)
- Advocate for Lowest Disposition Level or Lowest Probation Term
- Present Creative Alternatives and Solutions

Prepare Your Own Recommendations and Report

Report

- A. Ask for Specific Result
- B. Brief Court on Client's Background
- C. Carefully Highlight Mitigating Factors
- D. Discuss Client's Overall Progress
- E. Emphasize Appropriate Services

Prepare Your Own Recommendations and Report

- Affidavits of Support
- Letter of Apology or Explanation
- Certificates of Achievement
- Client's Creative Work- poetry, essay
- Report Card/Progress Reports

Protect the Record

Object to information that is not "relevant, reliable and necessary"

§7B-2501(a)

- Review Court Orders
 - Check for Specific Findings of Fact
 - Review Disposition Work Sheet

Project Positive Attitude

- Give a "Closing Statement"
 - Describe why plan is appropriate
 - Emphasize Belief in Client's Compliance and Success
- Empower Client
 - Give Client copies of orders
 - Review terms and conditions
 - Give relevant contact information
